# BIOTRANSMITTERS

## A revolutionary concept in medicine and cosmetology !

---

### UNKNOWN SUBSTANCES HIGHLY EFFECTIVE

**BIOTRANSMITTER:** a key concept in the medicine of tomorrow. What are biotransmitters, you ask? They may only be defined by their function: they transmit information to living organisms. The effect of such information may be to damage or to heal. The following may be biotransmitters: precious stones, metals, magnets, electronically programmed carrier fluids, discs, cards or amulets, but also laser and other rays, for example so-called earth rays.

As an example of the latter, the Swiss scientist André E. Oefeli and founder of PHI-LAMBDA TECHNOLOGY® illustrated in the first part of this report how the secret good and evil doers have their effect. The second and third parts are concerned with precious stones and electronically programmed Biotransmitters, which will probably have a large part to play in medicine, gene technology, biology, cosmetology and associated fields in the near future.

#### Part 1: Earth rays and other bioenergetic radiation phenomena.

Biotransmitters are objects or substances, which are able, without exception, to heal (or to damage), for example through being worn next to the skin.

Only the concept is new, and not the knowledge that Biotransmitter effects do exist. They have been used for many thousands of years, in China, India, Egypt and Africa for example. Primarily precious stones and metals have been involved, but also other organic and inorganic materials.

Let us take the example of the amulet. It was and still is considered a bringer of luck and good health. Although people are inclined to dismiss this as superstition, there is food for thought in the many written accounts of the effectiveness of such amulets. Are we dealing here with active factors for which no scientific explanation can be found?

Even wearing certain precious stones acts as a protection against illness and in maintaining vitality. Today attention is again focused on gem medicine. Healing with precious sto-

nes does not always involve taking them in powdered form. Success can also be achieved by placement on certain parts of the body, acupuncture points for example.

Biotransmitter effects also have a role to play in other therapies: for example in colour, laser and music therapies. This achieves reactions in the organism by means of "radiation information".

Mother nature herself offers many examples of so-called biotransmitter effects. Witness the orientational ability of many insects, in tracing the female from kilometers away. It has been proven that this cannot be direct scent reactions which would be impossible over such large distances. Clearly, what we have here are biotransmitter effects.

How do such biotransmitters work? Evidently by the transfer of radiant energy. Bioenergetic "Radiation information", which is transferred into the organism, can trigger reactions in this organism, by the wearing of a biotransmitter on the body.

We have not long had the technology which makes it possible for the naked eye to see such phenomena.

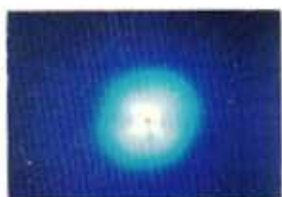
In this way, for example, the famous German physicist, engineer, and researcher Dieter Knapp was able to develop equipment which enabled him to photograph, in a way similar to the Kirlian method, bio-energetic radiation. This is the so-called "Plasma print and "Colour plate" method. Such procedures demonstrate particularly well biotransmitter effects.

With water for example:

Water is capable of storing bio-energetic information and releasing it again. Of course the storage capacity is dependent on the water quality.

If water is allowed to flow over a steel plate, bio-energetic information can be transferred from the steel plate into the water. (Signals may be stored in the steel plate, not unlike a tape recording).

The steel plate may have a positive or a negative influence on the bio-energetic potential of the water. Like the steel plate, other substances such as minerals, metals or electromagnetic coils can change the bio-energetic "transmission" of the water. These too are biotransmitter effects. The following photos, taken using the Knapp colour plate equipment demonstrate this effect:

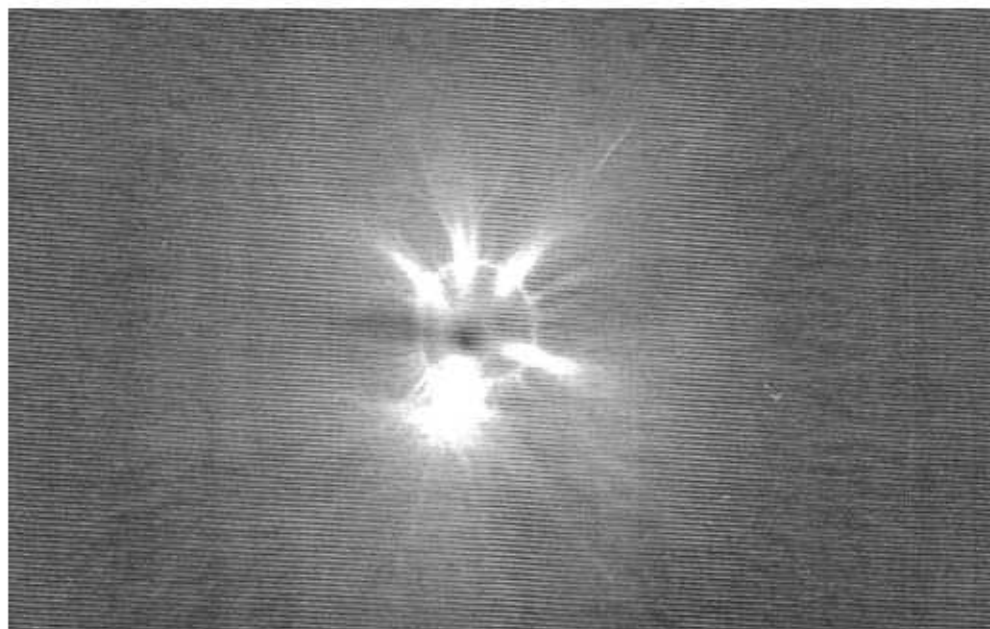

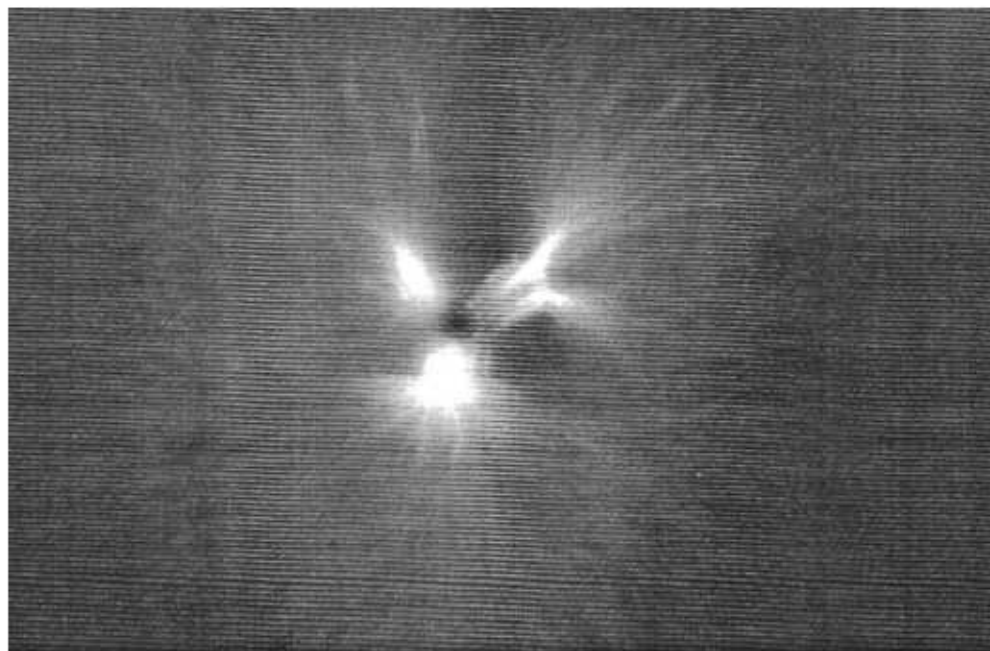
The Swiss scientist and bioenergeticist André E. Oefeli built apparatus for this purpose which is able to "superimpose" bio-energetic information electromagnetically onto substances or carrier fluids, by means of a computer aided procedure, and with the help of so-called "Tesla slab coils". He calls this procedure PHI-LAMBDA TECHNOLOGY<sup>®</sup>. Over the last three years, this has best been publicised through the PHI-LAMBDA-PRODUCTS used all over the world.

More about this in the third part of this report.

These too are biotransmitter effects. The following photographs made using the colour plate equipment, demonstrate this effect:

The photographs clearly show the differing effects.

Water can extract bioenergetic information from its surroundings (source). This is how, for example, the reaction of water on various stones and earth samples was tested using the colour plate method. It is straight away apparent that the bio-energetic radiation from water is modified after the addition of only minute stone samples.

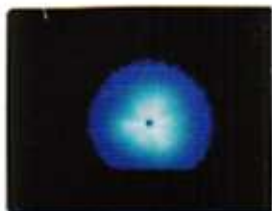

Known for some time to us, but not well accepted among experts, is the possibility of transmitting bioenergetic information by means of a magnetic field (as briefly mentioned above in PHI-LAMBDA-TECHNOLOGY<sup>®</sup>).

If one places an ampoule of water and a mineral between two magnets it is possible to transmit bio-energetic information via the magnetic field from the mineral into the water. Such transmissions are also possible in the earth's magnetic field. If ampoules of water are placed on various soils or on distortion fields, the water then picks up bio-energetic information from the earth. With the colour plate procedure it is possible to prove this.

It is therefore not unreasonable to assume from this that the human body or an animal body, consisting of about 70% water, can pick up such bioenergetic information, if it remains in one place for a sufficient time – the same applies to plants.

Example: In one residential area an unusually high number of people died within a short time of one another. The majority from cancer, some from leukaemia or cardiac infarction. Moreover in this area there were suicide attempts as well as nervous diseases. Dieter Knapp first undertook a radiesthetic investigation of this area (with a divining rod). The tests allowed conclusions to be drawn on distortion fields. Then he carried out further physical investigations.

The radiesthetic tests showed clear differences between the left and the right sides of the street. Soil samples showed that on the left the ground was made of various clay layers and on the right the ground was predominantly sand.

Using the plasma print equipment the radiant energy from the fingertips of various people living in the left hand side houses (standing on the clay area as well as those from the right side houses (sandy ground) were photographed. The tests show clear differences between people tested from the left and right sides of the residential area. Moreover it was shown that all people tested from the left side had significant health problems.

Now the question arises as to what happens within the human body as an effect of harmful distortion fields.

Colour plate tests show that water reacts to bio-energetic signals. From this we may assume that human blood too reacts to these signals. Numerous investigations of blood serum were undertaken using the colour plate procedure.

From this it was observed that blood serum, like water, reacts to biotransmitter effects. For example blood serum was exposed to lasers, treated magnetically, exposed to UV rays etc.

Since blood serum obviously has a positive or negative reaction to these bio-transmitter effects, it can also react to the environment in which the body is found. That is, the bio-energetic information of the blood can be influenced by the environment. The environment can also be a distortion field caused by various sorts of underground activity.

Test results lead us to conclude that the bio-energetic "Radiant information" of the blood system becomes modified if the body remains for any time in a distortion zone.

Naturally the opposite effect is also present here, if the organism is present once again on so-called "healthy ground". This is generally referred to as convalescence.

To find out more about distortion field effects Knapp also carried out bio-energetic test series with soil samples. The samples were taken from the ground in distortion zones, and from neutral zones. Here too differences were clearly visible.

Such investigations led us to believe that it is possible to weaken or even eliminate any distortion effect on the organism using a specifically programmed biotransmitter.

## Part 2: The bio-energetic power of precious stones

Before we can understand the effect of precious stones as biotransmitters, we must first appreciate the influence of colours on people. People cannot live without colour. After the monotonous black/white of winter time we look forward to experiencing at last the longed-for green of the meadows, enriched with many coloured flowers.

Our forefathers were nourished to a large extent from plants, and accordingly the colour green has come to be associated with security and life. As long as nature was green, one could look calmly to the future. Green stands for confidence, hope and relaxation: green calms and has a settling effect.

Brown is the colour of the earth. In the bowels of the earth, mankind found his bed and his security. Brown stands for security of the firm earth under foot, for roots.

Blue is the colour of the sky. From inside a 'plane, high above the clouds, one can gaze upon the radiant clarity and majesty of this colour. Blue is the symbol of inner peace. Blue means distance and light and confines fear.

Red, on the other hand, is the signal for danger and aggression. Red is the colour of blood and of strife; the colour which sounds alarm bells in the nervous system. The expression "seeing red" is very apt.

Yellow is the colour of the sun. Yellow activates, starts the motor of life, gives courage and confidence.

The two "non-colours", black and white, have particular effectiveness.

White contains the whole colour spectrum and amplifies the effect of each other colour. Red has, for example, a still more aggressive effect together with white.

By way of contrast, black is an all absorbing, completely neutral colour, which doesn't allow any rays to penetrate outwards. Black, the colour of priests and mourning, depresses the emotions, and blocks radiation.

Alongside the visible colour spectrum there exists a large range of invisible colour frequencies, which cannot be perceived by the naked eye.

To this category belong, for example, the frequencies of ultra red and ultra violet rays.

All living systems - people, animals, plants - are enveloped in (usually invisible) colour circles. This can be seen very easily by looking at objects through a glass prism. If one looks at, for instance, a finger through this prism, then one sees that it is surrounded by an aura of rainbow colours. Illnesses can be read from changes in this colour field.

There are other influences which may affect a change in the colour radiation in a body's aura. This includes factors such as weather, season, psychic and physical factors, and the influence of colours, either directly or indirectly, through skin, clothes and residence.

If colours can have both a positive and a negative effect, there must also be the possibility of using colours in a specifically therapeutic manner. This is done using colour therapy: how this works is sketched briefly here using a few examples. Colours can have a visible effect on the optic nerves and an invisible effect through the skin.

Colours also effect the body in darkness. This too could be proved by the plasma print method.

One therapy which is particularly effective, is that in which the colour is placed on meridians and meridian points.

Natural silk (2 x 2 cm) has been shown to be the ideal transmitting medium. If one places the relevant coloured silk pieces on the correct places of the body, then astounding therapeutic effects can be obtained. The colours can be worn for some days beneath clothing and are effective day and night.

The manner in which the effect is achieved through the skin can be explained by the Bio-transmitter effect. One can wear colours, but also other materials such as wood, metal or minerals and achieve results with them similar to using amulets. For example already possible today to programme in colours in certain materials, even in fluids, metals or plastics, in order to achieve specific biotransmitter effects.

Nature provides the best example here. The

best colour bio-transmitters are minerals and precious stones. Precious stones are, — looked at philosophically — compressed colours of a high degree of purity, (caused by the atomic structure in the crystalline composition) and therefore especially good for therapeutic purposes.

This method of healing is called gem therapy: a method which is thousands of years old, originating from the healing culture of India, Egypt and China.

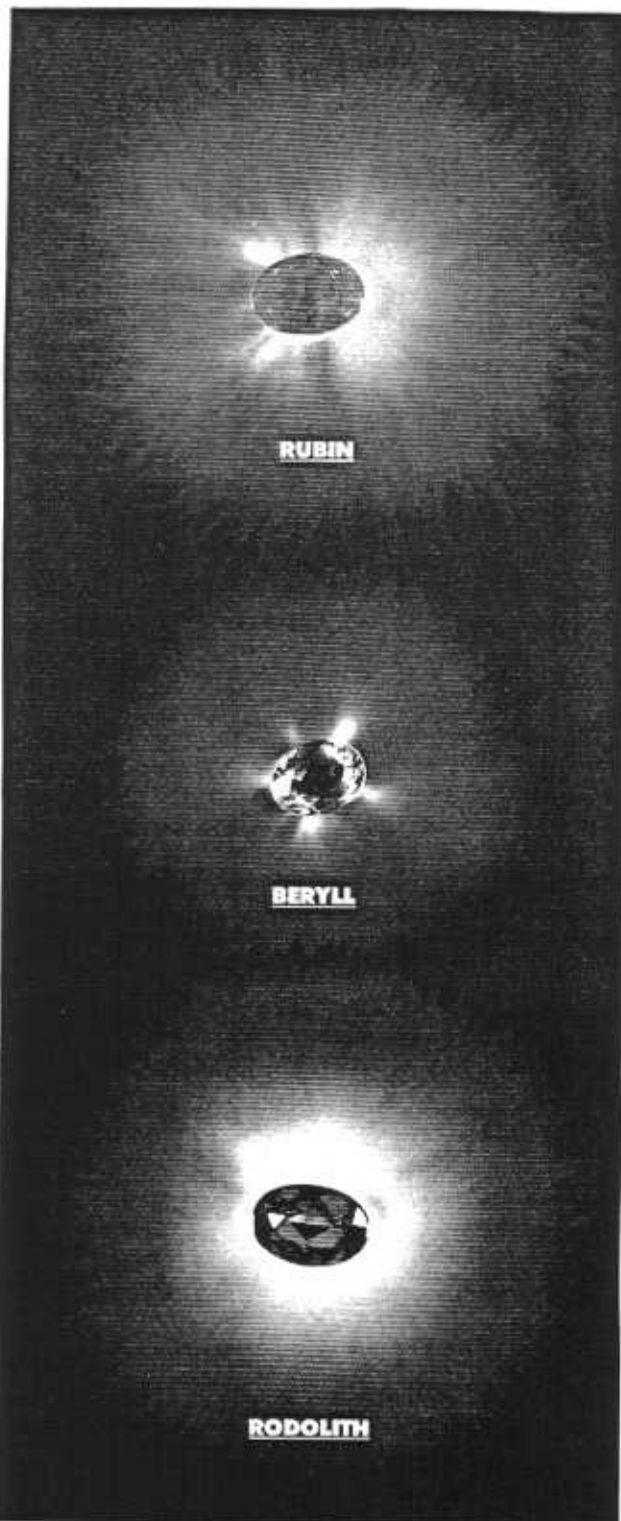
This ancient knowledge has been systematically collected for example in the Indian Ayurveda medicine: the methods are still practised today by ayurvedic doctors.

There are various opportunities for using precious stones in therapy. Mostly the ash of the burnt stones is taken as medicine or rubbed in. In my opinion however it is not so much the colour information having its effect here as the bio-transmitter radiation from the elements involved in the composition of the crystal, much as in homoeopathy.

A further possibility is to make tinctures from precious stones, where either stones are stored over a period of time in water or in other liquids or the precious stones are milled down into microscopically fine dusts and taken in liquids.

One method of healing consists of leaving the stones to work their effect on defined places on the body. This is reminiscent of the so-called breast plate of the "High Priest". Various stones were placed in various formations on this plate, which was usually made of gold. As a variation on the plate, there were also breast cloths with stones. No agreement has been reached to date on the arrangement and nature of the stones on the plates and cloths. Probably they were specially chosen

and put together for the wearer of the day. Similarly today various precious stones can be specially put together today as healing and harmonising biotransmitters for a patient.

So precious stones transmit quite distinct information by means of their bio-energetic radiation, and the organism reacts to this. It is possible, using Dieter Knapp's colour plate method already mentioned, or with the help of Dr. Fritz Albert Popp's photon spectroscopy, to make these bio-energetic transmission from the stones at least partly visible and to investigate them. However these emissions reach far into the dimension invisible to humans and are accordingly not directly recognisable on the radiation image of a colour plate photograph.

These interesting images (see previous side) particularly emphasise the beauty of these precious stones. Each stone possesses specific and traditional properties and has a particular effect. Special emphasis must be given to the fact that precious stone therapy must only be carried out by trained therapists. Each stone can react positively, but also in some circumstances negatively, if used at the wrong time or by someone in whom it amplifies disruptive influences, instead of having a harmonious and settling effect. For example one should not give a red stone which strengthens this tendency, to an aggressive person. This brings us to a description of the effects of the various stones, of which we are only able to briefly outline a few here:

**Emerald** helps with eye infections, heart complaints, ulcers, circulatory head aches, neuralgia, as well as with asthma and skin burns.

**Diamond** opens up a broad spectrum of radiation. It creates order and strengthens physical strength. The diamond is mostly used as a strengthening element in conjunction with other stones. It is recommended for lung diseases, whooping cough, asthma, nose and ear complaints as well as for festering tonsils.

**Sapphire** calms the over-sensitive nervous system and is used for nervous disorders. It reduces pain and is recommended for neuralgia, sciatica, tumours as well as various skin diseases.

**Coral**, actually not a stone, but the lime shell

on the sea bed of living coelenterates, is mainly used in stomach complaint therapy and disorders of the digestive system such as flatulence, constipation or haemorrhoids. Coral is also helpful with liver function disorders, and skin irritations as well as eczema.

With **topaz** a distinction is made between yellow and blue stones. Both may be used for tonsil complaints and inflammations of the throat, in measles, chicken pox, fits, epilepsy, inflammations of the bowels, nervous sleep disorders, gall bladder disorders and in jaundice.

The **amethyst** is always helpful for complaints arising from intellectual excesses, for difficulties of concentration, extreme strain and stress. With physical exhaustion too the amethyst brings relief and makes for stability.

The **amber** is not actually a stone, but the fossilized heart of long dead trees from antiquity, but plays a large part in precious stone therapy. It is used in cases of earache and with poor eyesight, stomach aches, kidney diseases, rickets, and with certain rheumatic diseases.

The **pearl**, really not a stone but a little ball secreted by molluscs, mostly pearl oysters, made of calcium carbonate. It affects the lymph system and ensures that the organism can absorb more moisture. Pearls are used in chronic asthma, fevers showing mucus, bronchitis, gout, chronic rheumatism, inflammations of the kidneys, gall stones and amenorrhoea.

The **ruby** activates blood circulation and helps with low blood pressure, weakness and weariness, but also with illnesses of the lungs, such as colds or bronchitis.

**Beryl**, the effect of which lies somewhere between that of emerald and the yellow sapphire, is used in rheumatic illnesses, neuralgia, headaches, colics, heart complaints, itching and nervous disorders.

**Rhodolite** is comparable to granite. Both stimulate the sex drive and offer help with illnesses of the sex organs,

The most recent knowledge in biotransmitter research has shown that one can remove and store the "healing signals" of precious



stones in biotransmitters. These "programmed" biotransmitters also lend themselves to use for healing purposes. By this method one can program in not only gem stone information but also other, for instance, homoeopathic information.

Currently two types of biotransmitters are being used in research, the passive and active biotransmitters.

The passive biotransmitter consists of a small housing or sleeve into which a defined

mineral compound or metal alloy is built. The biotransmitter thus formed can transmit signals which can be picked up via the skin, mainly from the meridian points.

The active biotransmitter can give off bio-energetic healing signals in a controlled manner. Usually it consists of a controlling device and one or several light or magnetic transmitters which are set up on the places of the body to be treated.

### **Part 3: Programmed liquids make medication superfluous.**

**The programmed biotransmitter brings the medicine of the future today. The future belongs to programming. Recently in bio-energetic medicine, biology and cosmetology: specially programmed carrier fluids, cards, objects like amulets, or transmitter equipment are transferring healing effects, are able to harmonize and strengthen. The results of modern biotransmitter research, above all PHI-LAMBDA TECHNOLOGY<sup>®</sup> from the Swiss scientist and bioresearcher André E. Oefeli open up breathtaking perspectives.**

New discoveries from biotransmitter research have shown that there is the capability to transmit healing signals from precious stones, homoeopathic substances or even from vibrations from living systems such as human or animal bodies and plants into other materials. In the same way that the human organism can receive these healing signals, they are picked up and stored by liquids, minerals, metals and even by special plastics.

Many liquids, especially water, show a particularly high receptivity to these "transmitter signals". Certainly these liquid transmitters, as they can also be referred to, usually release the picked up signals relatively quickly again. For some purposes this can be advantageous, for instance in enriching oxygen with negative or positive ions for medicinal practice. It has been shown that ionised oxygen is taken up and processed considerably more quickly by the organism, than normal oxygen. With patients having an oxygen deficit this treatment has very good results.

In contrast to liquid or gaseous transmitter materials solid transmitter substances (for

example metal or special plastics) usually have their own method of transmitting the stored information considerably more slowly and more reliably. The "transmitting times" can be months, but also a few thousand years.

The PHI-LAMBDA-biotransmitters programmed with a technical procedure of their own developed for this purpose, came into being, over a research period of about 15 years, mainly in the fields of the human mind, physics, medicine, molecular biology and genetics.

It was possible for the first time, with the pioneering PHI-LAMBDA TECHNOLOGY<sup>®</sup> to "superimpose" bio-energetic information onto carrier liquids or solids, which can transmit their "bio signals" practically without loss for centuries to living systems. Dr Burkhard Heim, the "Einstein of the 80's" coined the name "Quantum medicine" for this in 1988.

Since 1977 the German Doctor of Medicine Dr. Gorenfloss has used biotransmitters in his practice with impressive results. Dr. Gorenfloss writes, in his statement on bio-energetic

medicine,: "Bio-energetic medicine is a new direction in research, which differs from all former therapy methods in that its form of medicine represents the substance of a pharmacopoeia converted into energy.

For this it takes a special place within all branches of medicine.

It is the pure science of natural healing. It seeks to enforce the laws of nature and their principle of order and to fit the art of healing more nearly to this principle of order, or arrange it harmoniously.

It overcomes inflexible dogmatic thinking, and gives priority, in place of materially mechanical concepts, to the "Living" in all its functions.

Bio-energetic medicine offers new thinking initiatives to all branches of medicinal science and wants to give new impulse to the natural sciences which have fallen by the wayside; is classified amongst creative thought: visible creation presupposes the existence of one (or several) creative spirits.

It postulates that matter arises through the joining of energies and accordingly can be undone again, and that the world has a bipolar form.

Bio-energetic medicine is significant for all areas of medicine, in particular for pharmacology and toxicology. Not only does it represent a new direction, but it is also a factor in overcoming obstacles for the science of healing as a whole. Its aim is to create the intertwining of the many competing directions into one communal, binding and theoretically acknowledged basis for medicine, in order to bring an end to the struggle over opinions and the power struggle associated with it."

Building on the experiences of Dr. Gorenfloss two biotransmitters came into being at the end of the 80's: one for men and one for women. These are very precisely programmed biotransmitters, which take account of the biological differences between the sexes. Since the hormonal functions in men and women partly make a considerable difference, this is of great significance to **this method of transmitters**.

These transmitter cards, which work on the body, can be used as first defence against

bio-energetic deficits in humans. Bio-energetic deficits can, for example, be triggered through "Fthn" illness or other effects of the weather, through stress, through "geopathic" distortion fields; lengthy VDU work, and basically through all physical and psychic long term stress. Biotransmitters effectively support every other therapy.

Let us take an example from a series of tests, in order to demonstrate the effect of these cards. A test person had been under geopathic strain for a long time (through the harmful effects of earth radiation). For about eight years she had slept on a distortion field and was virtually resistant to therapy. Constant fatigue, head aches, digestive problems as well as ever worsening depressive phases, were placing considerable strain on the female patient. The diagnosis suggested severely degenerative strain in the whole organism, mainly in the digestive tract.

The patient was simply treated once with homeopathic means and was given a biotransmitter, which was worn day and night. After only 14 days the result of the test was a considerable improvement. After six weeks the patient was once again completely fit and free from problems. That was a year ago. The patient is still extremely well to date. We cannot tell yet how many applications might yet be revealed by biotransmitters in the future. Going by the position today, one can assume that in this sector much new ground will still be opened up. So it is possible, for instance, to make various products such as natural cosmetics, natural medicines and foods durable by means of biotransmitter effects.

In addition there are interesting research results, which draw the conclusion that with biotransmitters improved combustion and efficiency can be achieved in combustion motors and heating systems.

The Austrian Doctor of Medicine, Hubert Palm, developed a further interesting biotransmitter. His transmitter was not programmed but built and developed according to a completely different principle.

At the beginning of the 20th century, in Paris, the scientist Georges Lachowsky, who came from Russia, working with the French academy and European clinics on copper os-

cillatory circuits, healed cancer in plants and considerably improved cancer in humans. The efficacy of the Palmisch biotransmitters rests in the findings of this research.

We are not talking here about a card, but about a housing, in which several dipoles, (oscillatory circuits) are embedded in cellulose. Each dipole consists of a different metal and possesses a different resonance frequency. There are other oscillation relationships present here which together reveal a larger oscillating area (frequency spectrum). The effect of this biotransmitter is dependent on the effect of certain planets on certain metals:

In the year 1934 the pioneering group Pfeiffer Kolisko proved in one work that metals have a bio-energetic relationship with the planets surrounding the earth. Thus gold showed a reaction to solar radiation, silver to moon radiation, copper reacted to the effect of Venus and iron to Mars. The graded image method was used for this investigation. A salt solution of each metal was made and emptied into a test tube. Next a chromatographic paper was placed in the solution, (absorbent paper); the solution rose up this and gave a reaction figure. These reaction figures were of particular beauty and order, if certain planets were able to send their radiation to the earth. If, however, a planet such as Venus was obscured by the moon, then the copper graded image collapsed chaotically, whilst the other metals, such as gold, silver or iron remained unaffected.

The results of this interesting pioneering work showed that certain metals must have an affinity with certain planets and that so-called "powers for order" emanate from the planets.

Today we know from other pioneering work too, that enormous "powers for order" emanate for example from the sun, which are vital to life for us and our planet.

According to Dr. Palm, the biotransmitter has already proved itself in medical practice. The effect is confirmed by the therapists using them. Problems such as backache, blistering, constipation, arthrosis and others responded successfully to therapy according to medical information. One can say, as a rule, that this

equipment basically improves and harmonizes healing tendencies.

Likewise since the end of the 80's, there has been a biotransmitter on the market, made from a triangular plastic plate, into which a metallised film was built. According to the information from the inventor Dr. H. K. Kinas, special oscillations were programmed into this film, which have a transmitter effect. This card differs from other transmitters in that it can be reprogrammed. It can be changed in respect of effect and specially tuned to the wearer. After a time it loses its effectiveness however, this can be advantageous for therapeutic use, if a certain length of effectiveness is desired, for example with children or travel on land or sea. The biotransmitter basically supports all therapeutic measures.

The smallest biotransmitter known to us is the size of a normal pearl and consists, according to its inventor, Günther Falot, of a high quality gold platinum alloy. It is smelted using a special procedure and finally purified. Colour plate investigations showed in fact a massive settling effect in water (for example). The transmitter decreases the surface tension of the water and simultaneously transmits bio-energetic information mainly in liquids. Since the human body is composed of about 70% water and all life develops in and with water, one is entitled to make the assumption that this transmitter effects the water balance of the organism in exactly the same way as all other biotransmitters. It brought goods results with physically caused depressions, skin allergies and burns. It is also interesting to note that massages, after previously spraying the skin with water treated with the transmitter, showed considerably improved results.
