from the point of view of

PHILOSOPHY:

Let us ask ourselves the following questions:

Where do atoms come from?

How are they created or conceived?

By whom?

What kind of birth cycle do they go through?

How are things born?

Since mankind has existed, people have certainly been asking themselves questions like this - and if we want to make any progress in **natural sciences, philosophy or religion** we must find practical answers to these questions.

At this point, let us take a look at the simplest atom of all - the hydrogen atom.

Even a simple hydrogen atom has to be born!

A hydrogen atom possesses an electron. What power is responsible for moving this electron around the nucleus?

It is said that this power comprises electromagnetic force attracting the nucleus and electron to each other.

But the schoolbook scientists still have no idea what electromagnetism is. Neither do they know what gravity is - and least of all have they any notion of the nature of an electron!

So what is electromagnetism?

Is it the root cause of everything?

Or is it just caused by something else?

For if electromagnetism were the root cause of everything, we could say that electromagnetism is equivalent to the Almighty - but that would be absurd.

Do you think this little hydrogen atom was simply created by accident?

Or if a million tree trunks were thrown into the air, do you think there is a chance that sooner or later they would fall to earth in the

shape of a log cabin?

EVEN IF WE TRIED A MILLION TIMES - WE COULD NEVER EVER BUILD A LOG CABIN THIS WAY.

A log cabin cannot be created without a **plan**, drawn up by an architect or a **creative spirit**. And the more sophisticated the creation - from the hydrogen atom through higher atoms to the entire structure of the human body - the more complex the plan becomes.

Do you really think this is all done by accident?

Obviously there must be some creator behind the whole thing - a will or intention - otherwise nothing would happen at all.

FROM NOW ON WE SHALL DESIGNATE THIS FUNDAMENTAL CREATOR OR SPIRIT AS THETA, THE EIGHTH LETTER OF THE GREEK ALPHABET.

There is nothing on earth or in the entire universe which was not originated by this THETA.

Even apparently dead objects such as crystals are alive, and each individual atom has a life of its own.

They were all give life by somebody !

THEY ALL REPRESENT DIFFERENT FORMS OF THETA - OF LIFE.

And there is one kind of **THETA** which gives your body its vitality.

When this **THETA** is no longer present, your body is no longer alive.

But live exists - THETA exists !

When an architect creates something, his life force (**THETA**), his will and intention are

build into his creation !

If we take a closer look at the universe in which we live, we see that we are **always** dealing with one or more of the **three following categories**:

1. The THETA category

The creator, architect, originator, spirit, etc. – **the person as spiritual element**.

The **THETA** category (eight letter of the Greek alphabet) – **as creator of things or life forms** – can best be classified under applied philosophy or religion.

2. The LAMBDA category

The **LAMBDA** category (11th letter of the Greek alphabet) covers **THETA-created LIFE FORMS** - or the factor which adds a **further spiritual dimension** to material, energy, space and time in order to **create vegetable, animal or human life**.

In other words: LAMBDA is the factor which gives life to "lifeless material". The LAMBDA factor is enormously important in connection with living organisms. If our schoolbook scientists had known about the LAMBDA factor, a study of LAMBDA properties and behaviour would certainly be the most important aspect of biology, medicine and genetics courses - amongst others.

The **LAMBDA** factor will be examined and defined in more detail in a subsequent publication.

3. The PHI category

The **PHI** category (21st letter of the Greek

alphabet) covers the entire **physical universe created by THETA**, comprising **MATER, ENERGY, SPACE** and **TIME**.

The **PHI** factor - in other words the **physical universe** - is probably the most investigated and therefore the most familiar factor to schoolbook scientists.

Over the last few centuries a lot of excellent research work has been done to find out more about **PHI** structures, behaviour and laws.

In this connection another interesting question can be asked: what would be the effect on physics, chemistry and related sciences if the philosophical aspects - and thus the purpose or intention - of material, energy, space and time creation were taken into account in research projects?

What an interesting outlook for the future!

Conclusions

If we assume that both the **PHI** factor (material, energy, space and time) and the **LAMBDA** factor (life forms or vital forces) are manifestations of the creative **THETA** factor (architects, creative spirits), then we can draw the following conclusions:

- 1.) The **original intention**, part of the **power** and the **quality of THETA** are retained in creations (PHI and LAMBDA) after the act of creation as their most important characteristic, thus having a lasting effect on their behaviour and image.
- 2.) The **purpose** or **destiny** of **PHI & LAMBDA** is given by the **original intention of the creator (THETA)**.
- 3.) The common goal of both **PHI** and **LAMBDA** is **survival** - in other words **continued existence** through the course of time.
- 4.) Since **PHI & LAMBDA** creations are of spiritual origin (**THETA**), their existence is likewise of a **spiritual nature** - they are not just "dead material".
- 5.) One of the **most important** abilities of **THETA as CREATOR** is that of **communication** - in other words **the interchange of ideas, thoughts or particles between two or more terminals**.

This leads to the following types or levels of communication:

- a.) Telepathic communication between **THETA** and **THETA** (between creators).
- b.) Telepathic communication between **THETA** and **LAMBDA** (between creator and life form).
- c.) Telepathic communication between **LAMBDA** and **LAMBDA** (between created life forms).
- d.) Telepathic communication between **LAMBDA** and **PHI** (between created life forms and mater, energy, space and time).
- e.) Telepathic communication between **PHI** and **PHI** (between created mater, energie, space and time).
- f.) Physical-mechanical communication

between **PHI** and **PHI** (e.g. when we listen to music, physical sound waves impinge on our ear - made of **PHI** material - or when we have stomach-ache we take an alkaline medicine).

WHAT DOES TELEPATHIC COMMUNICATION MEAN?

If we take a closer look at the wide field of telepathy, we see that there are basically three bands (ranges or levels of activity) which are fundamentally different from each other.

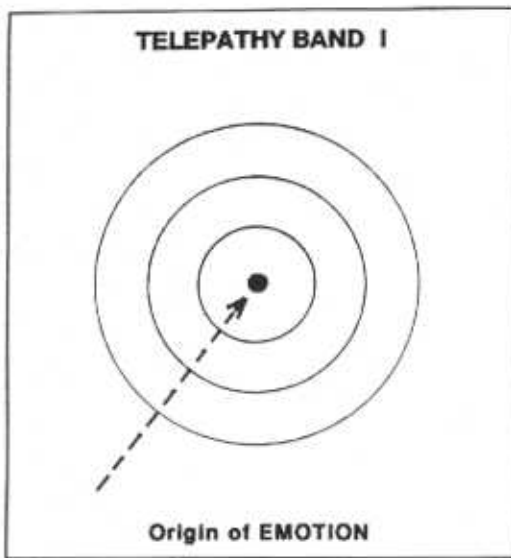
In contrast to physical-mechanical communications (microwaves, radio waves, sound waves, etc.), we assume that the source (starting point) of telepathic communications is always a spiritual being.

Telepathy band I = EMOTION

Have you ever entered a room and felt that somebody was angry? We can feel that someone is angry even if they do not say "I am angry" - we say to ourselves "Oh dear, he's angry". In the same way we can feel when someone is sad or happy - "what a happy person!" Why do we feel this person is happy? Why do we know when someone is feeling happy? Is it because we can see them smiling, or is it because they radiate something? Let us call this radiation **EMOTION**. In other words emotion is projected between the two persons concerned. This can be any emotion, including fear. We can see and feel when someone is afraid. You are walking in an area where a bomb has been laid, at the airport for example, and suddenly you feel afraid. You know nothing about the bomb threat, but between you and the other people walking around, the signal "fear, fear, fear" is constantly being transmitted.

We have emotional communication channels with other people, which work at a distance.

The diagram below shows typical wavelengths and spread characteristics for the emotional telepathy band.

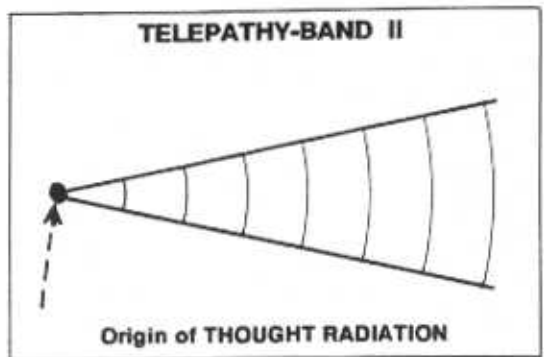


As we can see, these waves radiate concentrically from the emotional telepathy origin. They are radiated in all directions - everyone in the room can feel them, no matter on which side the person concerned is standing. This is not very good if you want to keep your emotional telepathy communications private - but it can be useful.

Telepathy band II = THOUGHT (energy beam)

Another form of telepathy is intuition - "my sister wants me to call her", or "I know my son is in danger, I have to call him immediately". These are typical examples which have happened on several occasions. Then there are stories of people who suddenly feel that something has happened a long way away. They get in touch with the place concerned - and find that it is true. How can we define this phenomenon? Since it is based on thoughts, let us call it THOUGHT. It is not necessarily emotions which are transmitted in these cases, but actual facts. The person concerned knows that "something is happening over there". We can therefore designate this as a level of consciousness or a thought level. This is much easier, since we are conscious of our thoughts.

Let us take a closer look at this:



We can get hold of our thoughts and put pressure on them. Have you ever seen a hypnotism demonstration where one person tries to control another through quantitative thought projection? For example the message "you must not open the door" can be put across without saying so. This is done by projecting a beam of energy - just like water flowing through a fire hose - which carries the thought concerned in the same way as a superimposed wavelength. Not all thoughts are transmitted in this way - usually they are extremely intensive because they are connected with some danger. Most examples of intuition and premonition are to do with the fact that someone is in danger and the other person is afraid, thus leading to a situation where they both "join forces" with similar energies to combat the situation. We can call this level of premonition "radiant energy", or thoughts with radiation energy.

The diagram below shows typical wavelengths and spread characteristics for the thought telepathy band.

As we can see, "thought telepathy" beams are directed much more intensively from the origin towards the recipient.

The further they get, the wider they become - in the same way as a water or air jet which is directed in a straight line.

Due to interference, etc., thought beams impinge on counteracting forces in the universe which scatter them in all directions until they finally fade away. This leads to the spreading of thought waves, and we can think of them as becoming wider in the direction of the recipient. Essentially what happens is that the thought beam scatters and loses intensity as it propagates and becomes wider.

I do not know whether the effect of thought

beams is mathematically quartered as the distance is doubled, in the same way as gravitation, solar energy or sound propagation. This usually applies to spherical radiation, and I am fairly sure that it also applies to thought beams.

Hence thought wave beams are considerably spread and scattered on their way to the recipient.

This is analogous to a laser beam transmitted from the Earth to the moon. It starts here as a tiny point of intensive light, and when it gets to the moon it has a diameter of about two metres. In other words it has suffered a certain degree of scatter, and if it went far enough it would finally disappear altogether.

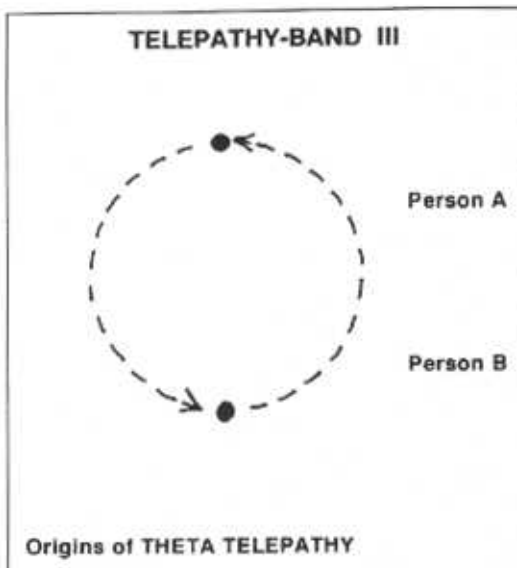
Hence thought beam telepathy waves are under much better control and better directed towards the recipient than emotional telepathy which simply radiates in all directions. This is why they are defined as controlled beams.

Telepathy band III = THOUGHT radiation (THETA to THETA)

There is one more telepathy band of which we know nothing, because only the first two bands have been investigated and are used during our time on the Earth. Band number three is thought at **THETA LEVEL**. The THETA LEVEL is concerned with the spiritual being, or consciousness of the person as a spiritual entity. This is the type of thought we have when we read something or when we simply think of something beautiful - when we observe and understand what we have observed. There is no particular emotion connected with this kind of thought, neither does it have any particular force. It exists at the level of observation in the form of extremely fine energy. This not to say that no energy at all is connected with this level of thought, but whatever energy is there is extremely light and fine and very, very apart - almost outside the physical universe. This is the THETA level.

The diagram below shows typical wavelengths and spread characteristics for the THETA telepathy band.

As we can see, this type of telepathy does not comprise a beam, hence it does not



spread or scatter in the normal sense.

Hence if **person A** in London communicates telepathically with **person B** in Manchester at this level, they are communicating via their **consciousness**.

In this case all the intermediate stations are eliminated, and we are left with **pure knowledge or consciousness**. Person A is in direct telepathic communication with person B if he can **duplicate** him. Not only can he do this, but he knows that his duplicate is person B.

Hence what person A is really doing is to **impart a desire** for communication to person B so that the two are connected over a distance. The resultant effect is the **sum** of the two, and each person duplicates what the other does - just as if he were to look over the shoulder of the other one and copy his actions.

So much for the theory behind these three telepathic bands. I hope it was not too much for you, but I feel it was necessary to define what I mean by telepathy in order to make myself understood in the following chapters.

Let us examine how we can experience and observe points 5a to 5f in daily life:

TELEPATHIC COMMUNICATION BETWEEN THETA AND THETA

This is defined in parapsychology as comm-

unication between two or more persons (spiritual beings) at purely spiritual level without using speech or other communication aids. Telepathic communication between THETA and THETA is one of the best known and most widely recognized examples of "supernatural experience", and is designated in everyday language as thought transmission.

TELEPATHIC COMMUNICATION FROM THETA TO LAMBDA TO PHI

This area includes for example the so-called placebo effect.

From the philosophical point of view the placebo effect works medically as follows:

1.) Since he believes in the doctor's authority, a THETA (person as spiritual being) is convinced that the prescribed sugar pills will help to reduce his blood pressure.

2.) This THETA telepathically transmits - either consciously or (usually) unconsciously - his conviction or assumption to his LAMBDA organism, which is responsible for the vitality of his blood cells.

3.) The LAMBDA organism take over this idea or assumption for organizing, structuring and revitalizing the blood cells.

4.) Since the LAMBDA organization is likewise convinced that the sugar pills will help to reduce excessive blood pressure, it transmits this idea or assumption to the innumerable PHI factors.

5.) The PHI factors forming the blood cells (chemically) are now restructured by the LAMBDA factor - leading to yet another "miracle cure".

TELEPATHIC COMMUNICATION FROM LAMBDA TO LAMBDA AND LAMBDA TO PHI

If we examine the human body, we see that it comprises a gigantic organism of LAMBDA-energized cells, cellular structures and organs. As we have already seen, it is the LAMBDA factor (life forms) which structures the PHI factor (mater, energy, space and time) into a living organism and gives it life. In other words, the LAMBDA factor makes the

essential difference between a "dead" piece of veal from the butcher and the living calf in the stall. Both are the same animal, but the latter has life - it loves to drink cow's milk and enjoys licking a salt block.

In contrast to the PHI factor, which we can measure or see (if present in sufficient quantity), the LAMBDA factor is more of an ethereal nature - we can see it neither with the naked eye nor under the most powerful electron microscope.

However the Kirlian photography process at least allows us to make LAMBDA-structured PHI visible on a photograph. But what we see is only structured PHI particles.

Hence LAMBDA is an extremely ethereal factor. **LAMBDA creates, retains, promotes, destroys and alters PHI. It collects, groups and scatters it. LAMBDA survives by vitalizing, mobilizing or destroying material and energy in space and time.**

And all this is achieved by telepathic means - no ideas or intentions are transmitted verbally.

This is probably the **greatest problem of gene technology**. As long as the LAMBDA factor is not included in their research work, gene technologists must be ready for a good many unpleasant surprises.

WHAT IS A LIVING CELL FROM THE PHILOSOPHICAL POINT OF VIEW?

If we take a closer look at a living cell, we see that there are two basic factors involved:

a) A collection or organism of PHI particles making up the chemically identifiable part of the cell.

b) One or more LAMBDA aspects, which organize the PHI particles and tell them how to work together and what biological purpose they have to fulfill.

Particularly interesting here is the statement under b).

It is the ethereal LAMBDA aspect which determines the form and task of each cell, and not - as wrongly assumed in gene technology - the visible DNA or chromosomes!

I know this statement totally conflicts with

the latest scientific findings - but the correctness of this bold theory is proved by the fact that PHI-LAMBDA-TECHNOLOGY® (works 100 percent.

For if we examine a chromosome or a DNA double helix under the electron microscope we see - quite logically - that the visible part of the DNA comprises nothing else than structured PHI particles!

As mentioned above, these PHI particles are vitalized and organized by the LAMBDA factor. In other words the actual hereditary information of the DNA is not identical with the visible PHI particle - it surrounds or permeates the DNA-PHI particles in the form of the LAMBDA factor.

For some gene technicians this may be the answer at long last to the following question: why do gene manipulations on living cells work sometimes and other times not?

The reason for this is certainly to do with the speed at which a DNA section is taken from one cell and implanted into another. If this procedure is carried out quickly enough, the LAMBDA factor can be transferred together with the PHI particles, but if it takes too long the LAMBDA factor is lost - and the experiment is a failure.

WHAT IS A LIVING BODY FROM THE PHILOSOPHICAL POINT OF VIEW?

A human, animal or vegetable body comprises an unimaginably enormous and complex organism of PHI particles structured and vitalized by the LAMBDA factor.

Individual cells are structured by the LAMBDA factor into cell groups or bodily organs, which are then LAMBDA-coordinated into a functioning biological organism - in other words a body.

The next question is: where does PHI-LAMBDA-TECHNOLOGY® (come into all this?

If we take another look at alleopathy and homeopathy in the light of the above statements, we now see that alleopathical agents mainly work on living organisms at PHI level, whereas homeopathical agents work one level higher at the LAMBDA level.

This explains the more subtle but more direct effect of homeopathical agents and the almost complete absence of undesirable side-effects - in contrast to alleopathical agents.

Based on these findings, the Swiss natural scientist and bio-researcher André E. Oefeli started to make detailed studies in the fields of biology, genetics, electronics, chemistry and applied philosophy.

For about 15 years he studied the principles of the vital forces (LAMBDA) behind life forms, their connections with cells and cell structures, and how they influence the latter.

He then achieved a decisive breakthrough in "programme troubleshooting at cellular level". He succeeded in finding out how electromagnetic or ethereal LAMBDA programme information is structured and stored for controlling cell functions. Furthermore he also found out how to repair "data errors" in these ethereal LAMBDA programmes.

From the technical point of view this is achieved by transforming a carrier substance - in the case of PHI-LAMBDA DROPS distilled water and alcohol - using a specially developed computerized process, so that it is able to transmit a repair programme to the cell structures by electromagnetic means. This enables the cells to put themselves back into optimal condition once more.

The details of how this is done and how the research worker can get at this "PHI-LAMBDA information" would go far beyond the limits of this brochure. These matters will be dealt with in detailed scientific documentation to be published at a later date.

In short, the PHI-LAMBDA information obtained through research is superimposed by means of a computerized electronic system on to liquid or solid carrier substances. This done by modulating the PHI-LAMBDA information on to an ELF scalar wave. The resultant information signal is then amplified and superimposed on the carrier medium in a Faraday cage via specially developed flat-coil devices.
